

TRUBLE INDICATOR RECORDS

INTERTOLL TRUNK CONCENTRATING EQUIPMENT

1. GENERAL

1.01 This section describes Forms E-3964 and E-3965 which are provided for recording trouble indications displayed at the intertoll trunk concentrating equipment trouble indicator frame in crossbar tandem and toll offices.

1.02 Form E-3964 "Intertoll Trunk Concentrating Equipment Trouble Ticket" is 4" x 6". It is provided for recording individual displays. It is also provided for recording concentrating equipment trouble data as explained in detail in other sections of the Bell System Practices. For the purposes of this practice, discussion will be limited to the trouble indicator portion of this ticket.

1.03 Form E-3965 "Intertoll Trunk Concentrating Equipment Trouble Indicator Record" is 8-3/8" x 10-7/8". It provides for recording as many as 25 displays on one sheet.

2. DESCRIPTION OF FORMS

2.01 The upper left-hand spaces on Form E-3964 and the column headings on Form E-3965 are designated to correspond to the lamp designations on the trouble indicator frame reading from left to right and top to bottom. These designations are explained in other sections of the Bell System Practices.

2.02 In some of the spaces it is necessary to write in one or more numbers. Other spaces should be checked to indicate that the corresponding lamp on the trouble indicator was lighted.

2.03 The use of these forms is optional. Either or both of the forms provided may be used in an office.

2.04 The right half of Form E-3965 has been provided for recording analyses of the troubles represented by displays, the trouble found or action taken as well as other miscellaneous data as indicated by the column headings.

2.05 Form E-3965 is normally intended for recording the information displayed on the trouble indicator frame. It is also used as a summary sheet for analysis purposes.

2.06 It will be found desirable to prepare a Form E-3964 on all displays which result in a found trouble within an office or for those cases which are referred to a switchman for investigation. This form may be used as a trouble ticket record of the found troubles resulting from trouble indicator frame displays.
